A RESOLUTION AMENDING RESOLUTION NO. 1-20, THE RULES OF COUNCIL (Rule 1 and Rule 16) PASSED ON JANUARY 6, 2020 AND DECLARING AN EMERGENCY

WHEREAS, Lorain City Council wishes to amend Council Rules to limit the number of regular meetings held monthly by the legislative authority during the to reduce exposure to our employees and the general public during the COVID-19 crisis.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF LORAIN, OHIO:

SECTION II: That Resolution No. 1-20 - Rule #1 - Regular Meetings which currently reads as follows:

RULE 1 – Regular Meetings:

The regular meetings shall be held in the Council Chambers on the first and third Monday evenings of each month promptly at 6 p.m. If the day of the meeting falls on a legal holiday, the meeting shall be held on the following day. Council shall recess during the month of August.

SHALL HEREBY BE AMENDED TO READ AS FOLLOWS:

RULE 1 – Regular Meetings:

Due to the emergency crisis, Lorain City Council will hold their regular meetings on the third Monday of each month for the next sixty (60) day period. Commencing June 1, 2020, all regular meetings shall be held in the Council Chambers on the first and third Monday evenings of each month promptly at 6 p.m. If the day of the meeting falls on a legal holiday, the meeting shall be held on the following day. Council shall recess during the month of August.

SECTIONI V: That this resolution is here by declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare in the City of Lorain and the usual daily operations of the City for the reasons set forth above and provided it receives the affirmative vote of at least two-thirds of the members of the legislative body, this resolution shall take effect and be in force immediately upon its adoption by Council and approval from the Mayor, otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
